




THE PROPOSAL TO DISCONTINUE A ROAD IS, IN MY OFINION FLAWED ON MANY GROUNDS.

THE 52 MAY, IN QUESTION WAS ILLEGALLY TAKEN ONER BY SOMETHIE MANY YEARS AGO, AND HAD THE AUTHORITIES DONE THEIR JOB, THE WRONGSOER WOULD HAVE HAD TO RETURN THE LAND IN QUESTION, REMOVE THE FENCE AT HIS/HER EXPENSE, AND BE FINED FOR HIS/HER ACTIONS.
