- All dogs and cats on the property must be registered with the Hobsons Bay City Council; (refer to clauses 10 and 16 of the *Domestic Animals Act 1994*)
- All dogs and cats must be under control or confined at all times; (refer to clauses 23, 24, 25 and 26 *Domestic Animals Act 1994*)
- Any permit granted will be subject to review following receipt of complaints;
- Animal keeping must comply with the provisions of the Hobsons Bay City Council Community Local Law, and in particular the permit holder must ensure that the keeping of animals does not cause a nuisance;
- Should one animal die, or you wish to replace it, or in the circumstances where the number of animals exceeds the existing permit, a new application must be lodged with Council.
- Failure to comply with these permit conditions could result in termination of this permit.
