Random spot checks will occur after 10 April.</p>

			Refunds	<p>If a dog or cat is desexed or is deceased within the first six months of the registration year the registered owner can apply for a partial refund. Supporting documentation is required. No refunds apply after 10 October each year.</p>
