

SCHEDULE OF FEES

STATUTORY AND STRATEGIC PLANNING



This is a summary of the fees prescribed under the Planning and Environment (Fees) Regulations 2016 and is not a complete representation of these Regulations. A complete copy of the regulations can be viewed at the Department of Environment, Land, Water & Planning website (www.delwp.vic.gov.au). This document also details the fees charged by Hobsons Bay City Council for a variety of Planning related documents and services. These fees are effective as of 1 July 2022.

Fees for applications for permits under section 47 of the Planning and Environment Act 1987 (the Act) (Regulation 9)

Reg 10	COMBINED PERMIT APPLICATIONS	
The fee for an application for any combination of matters set out in one or more classes of application is the sum of the highest of the fees which would have applied if separate applications were made and 50% of each of the other fees which would have applied if separate applications were made. For example, an application to construct or develop five dwellings on a lot and a reduction of the required number of car parking spaces would trigger two fee classes (Class 13, and 50% of the Class 22 fee).
