## Purpose

To provide a final update to Councillors and the community on the areas of focus for the 2021-22 mayoral term of Cr Peter Hemphill.

## Recommendation

That Council notes the progress made on initiatives and activities that were identified as focus areas for the 2021-22 mayoral term by Cr Peter Hemphill.

## Summary

The Mayoral Program provides an opportunity for the Mayor to support the implementation of key strategic actions that will serve the best interest of the Hobsons Bay community and align with the Hobsons Bay 2030 Community Vision and the Council Plan 2021-25.

## Background

In November 2021, Council elected Cr Peter Hemphill as Mayor for the 202122 mayoral term, and at the Council Meeting held on 8 February 2022 resolved to note the proposed 2021-22 Mayoral Program.

Cr Hemphill nominated four key mayoral focus areas: heritage, environment, infrastructure and community building. These include:

- preserving important heritage in Hobsons Bay such as the former Newport Railway Workshops, the Hobsons Bay Heritage Street Signs program and the historical significance of Altona Pier
- showcasing and advocating for expansion of the Virtual Energy Network
- rolling out the Urban Forest Strategy including a virtual dashboard for the community
- advocating and supporting delivery of critical infrastructure including:
  - continued advocacy for important projects such as the Hobsons Bay Wetlands Centre at HD Graham Reserve and the Western Aquatic Facility at Bruce Comben Reserve, both in Altona Meadows
  - collaborating with the Victorian Government to upgrade facilities at the Williamstown Swimming and Life Saving Club

- continuing to work in partnership with the Victorian Government and the West Gate Tunnel Project to deliver the WLJ Crofts Reserve Pavilion in Altona North and new facilities at Donald McLean Reserve in Spotswood
- o a new pavilion at JT Gray Reserve in Williamstown North
- supporting community development, including supporting Council's Citizen of the Year and Young Citizen of the Year in their community work and continuing Council's commitment to sister cities in Buloke, Yarrabah and Anjo

This report is the final in a series of regular quarterly updates on the progress made on these initiatives and activities since November 2021 when Cr Hemphill was elected Mayor. Cr Hemphill's term as Mayor concludes on 11 November 2022.

### Discussion

#### Heritage

The **Newport Railway Workshops** are home to some of Victoria's remarkable railway heritage buildings and moveable heritage items (such as locomotives and carriages) and is included on the Victorian state heritage register. Cr Hemphill championed heritage assessment work underway seeking to recognise significant rail heritage artefacts at the Newport Railyards. Following community work on possible additional heritage significance of the site, Council is undertaking a review to identify possible opportunities to better protect moveable heritage items at the workshops.

In recognising the cultural value of Newport rail heritage, Cr Hemphill facilitated connections in the creative industries.

A new public art and heritage app, **Experience Hobsons Bay Creative City**, includes the locations of signs installed under the Cultural Heritage Street Signs program. The app is designed to encourage people to explore the Hobsons Bay through its many art sites.

One of the sites promoted on the app is the heritage-listed Tide Gauge House at Commonwealth Reserve in Williamstown, which recently underwent conservation works.

Cr Hemphill worked with the Royal Australian Navy and the Australian Defence Force to support and participate in the celebration of the **80<sup>th</sup> anniversary of the HMAS Castlemaine** on 9 October 2022. Cr Hemphill visited on board the HMAS Castlemaine, engaged with volunteers and spoke at the official welcome held at the Royal Yacht Club of Victoria. About 3,500 people visited on the day, and the event was covered on television and metropolitan media.

The **100<sup>th</sup> anniversary of the Old Laverton School honour board** was held on 24 October 2022. Cr Hemphill spoke, along with family historian Rob Newlands, about the board's history of the board and the significance of two new plaques installed in the grounds at a community event held at the Old Laverton School in Altona Meadows. The event was attended by local historians, descendants of the Hyde and Newland families, residents and members of the Laverton Point Cook Rotary Club, which has been involved in protecting the building for the last 35 years.

Assisted by the Mayor, Council established a connection with local resident **Phyllis Murphy AM**. Mrs Murphy was acknowledged as a Member of the Order of Australia in the 2022 Queen's Birthday Honours List.

In addition to being noted for expertise as an architect and heritage conservator, Mrs Murphy has built a significant collection of heritage wallpaper. The collection will have a permanent home in the Living Museum of Sydney in 2023.

The opportunity to stage a local exhibition from this collection, featuring a curated collection of samples from the 1840s to the 1930s, was supported and announced in November 2022. The exhibition, titled "Off The Wall", is to be held at the Williamstown Town Hall in December.

#### Environment

Phase one of Council's ambitious **rooftop solar program** is nearly complete, with 1.7MW of new solar panels installed across the building portfolio. When added to existing solar assets this exceeds 2.2MW of solar panels which, modelling suggests, will generate over 3,000MWh of renewable electricity after a full year of operation.

Recent buildings to receive solar within the program include the Newport Gardens Early Years Centre (now complete) and the Hobsons Bay Civic Centre car park (currently under construction).

Towards Council's target under the **Urban Forest Strategy** of achieving 30 per cent canopy cover by 2040, 8,000 semi-mature trees were planted across Hobsons Bay streets and reserves in 2022. Council also gave away over 2,700 tube stock trees to residents for planting on private land at various events throughout the year, which will further contribute to the future canopy cover of Hobsons Bay.

In addition, Council undertook a tree planting program in partnership with the Department of Environment, Land and Water that resulted in an additional 20,000 tube stock trees being planted across open spaces within the municipality.

The **Green Streets program** allows Council to educate on and promote the importance of street trees while providing residents with an opportunity to contribute to tree selection and the future look of their street.

In 2022 the three streets selected to participate in the program were:

- 1. Grace Street, Laverton: 44 trees, a mix of *Corymbia maculata* "ST1" Lowanna and *Jacaranda mimosifolia*
- 2. Hancock Street, Altona: 25 Lophostemon confertus
- 3. Bayview Street, Williamstown: 79 Corymbia maculata "ST1" Lowanna

#### Infrastructure

Cr Hemphill has continued to advocate for, support and collaborate on the delivery of the following critical infrastructure across the city.

Council and the Hobsons Bay Wetlands Group continue to strongly advocate to all major political parties for project funding for the **Hobsons Bay Wetlands Centre**. The Hon Melissa Horne MP, the Hon Jill Hennessy MP and the Hon Lily D'Ambrosio MP visited the site of the Hobsons Bay Wetlands Centre on 15 June 2022 to discuss the importance of the project and the wetlands area.

Community consultation on the preliminary concept plan for the **Western Aquatic and Early Years Centre** took place from 15 August to 23 September 2022. As part of the consultation period, a household survey was delivered to residential properties in Altona Meadows, Laverton, Seabrook and parts of Altona, and the same survey was hosted online at Participate Hobsons Bay. Two onsite drop-in sessions were also held during the consultation period to provide residents with the opportunity to discuss the plans in more detail. Feedback from the community is being reviewed and the concept plan is will be updated before being released to the community. Concurrently, Council has been running a "Float our Pool" advocacy campaign which has attracted 862 signatures from the community. Council has engaged architects to prepare designs for the future upgrade of the **Williamstown Swimming and Life Saving Club facility**. Site investigations have commenced along with engagement with the club and other project stakeholders on concept design options. Community consultation on the concept plan is expected to occur in early 2023.

The **WLJ Crofts Reserve Pavilion** was completed in late September 2022. An event to mark the formal opening of the pavilion was hosted on 22 October 2022 by Cr Hemphill with the Member for Williamstown, the Hon Melissa Horne MP, in attendance. The Williamstown Superules Football Club also held their end of season event within the facility, which was a great success with over 150 attendees.

At **Digman Reserve**, construction of the east to west path from Home Road through to Douglas Parade has been completed. This was a key priority identified within the Digman Reserve Master Plan to ensure connection between the Newport Train Station and the Bay Trail. Open Space works at the western end of the reserve remain ongoing. Implementation of the Digman Reserve Master Plan will be complete upon finalisation of these works.

The W & M Couch Pavilion at **Donald McLean Reserve** was completed in time for the end of the football season. The Spotswood Football Club hosted their final home match of the season with access to the new pavilion, which was well attended by members of the community. An opening event was hosted by Cr Hemphill on 22 October 2022 with Member for Williamstown, the Hon Melissa Horne MP, in attendance. Car park works are being finalised along with the open space upgrades at the western end of the reserve.

Pavilion redevelopment works at **JT Gray Reserve** remain ongoing and are scheduled for completion in March 2023, in time for the start of the winter season. The new cricket nets and storage areas have been handed over for club use, and preparation for the redevelopment of the internal car park is ongoing. Planning continues for minor floodlighting upgrades to the site.

A new cricket practice facility was opened at **JK Grant Reserve** in October 2022, which will be utilised by the Altona Cricket Club. The facility features six synthetic wickets that complement the existing four wicket turf nets, and retractable netting to create flexible and multi-use spaces. The facility was delivered in partnership with the Victorian Government and Cricket Australia, which contributed \$90,000 and \$30,000 respectively to support Council's investment in the project of \$454,000.

#### Community Building

Cr Hemphill worked actively with Council's **2022 Citizens of the Year** to engage actively with Council in a range of areas. Young Citizen of the Year Tahlia Kotia spoke at a number of Council events including, for example, International Women's Day and the Hobsons Bay Youth Change Makers group. Citizen of the Year Kate de Marco became actively involved in Council projects including championing the Epsom Street Social and Affordable Housing project. Cr Hemphill also worked with Ms de Marco on a range of advocacy for people with disabilities in the community, leading to a commitment from Metro Trains to upgrade two pedestrian rail crossings in the municipality.

Council maintains a formal relationship or friendship alliance with three **sister cities**. Each was instigated and developed through reciprocal activities including community connections, information exchange, and at times direct support.

Yarrabah in Queensland is one of the most significant Aboriginal communities in Australia. The **Hobsons Bay and Yarrabah alliance** is recognised for strengthening Indigenous partnerships.

Cr Hemphill visited Yarrabah on 31 October 2022 to further the relationship between Council and the Yarrabah Aboriginal Shire Council and to build connections between the two communities. This marked the first mayoral visit to Yarrabah since 2012.

Yarrabah Mayor Cr Ross Andrews and interim Chief Executive Officer Richard Wright hosted the visit, which included meeting with Councillors and staff representatives, an overview of the Yarrabah Leaders Forum, exploring challenges and opportunities for knowledge sharing, collaboration and community engagement. The visit also involved conversations with community representatives including the principal of the Yarrabah State School and the rangers from the Prescribed Body Corporates, and visits to sites such as the Yarrabah Cultural Centre and community facilities.

Buloke in Victoria is a regional rural shire. The **Hobsons Bay and Buloke alliance** was formalised in 2006 to help break down the "urban/rural divide" and is recognised for its strength in community planning.

Cr Hemphill was to host and speak at the official functions for the annual Buloke and Hobsons Bay bowling club tournament at the Altona Bowling Club in September 2022. However, the visit and tournament were cancelled due to being scheduled during the week of the royal funeral and on the day proclaimed as a public holiday for the National Day of Mourning. Plans are underway to reschedule the visit, potentially in March 2023.

During October, Cr Hemphill was in contact with the Mayor of Buloke Shire Cr Daryl Warren to gain an understanding of the impacts of the flooding occurring, especially around the Avoca River, and potential impacts on the township of Charlton in particular. Offers of support were also made by the organisation, including ways for staff to volunteer skills and time. Some staffing support has now been requested and is being provided to assist Council's sister city in responding to the sustained impacts of the flooding and work as quickly as possible to help residents get back into their homes. Due to COVID-19 the **Junior Council** program was placed on hold throughout 2020 and 2021, so it was a welcome return to the Council Chamber on 2 November 2022 for the first face-to-face Junior Council Meeting in nearly three years. Cr Hemphill was impressed by the outstanding altruistic community spirit and the incredible fundraising efforts of all schools in the municipality raising money for a myriad of good causes such as flood victims, vulnerable communities in Ethiopia, Caritas and Autism Spectrum Australia.

Cr Hemphill presided over seven **citizenship ceremonies** during his mayoral term, conferring some 445 new Australian citizens. Virtual citizenship ceremonies were held on 30 November 2021, 26 January 2022, 22 February 2022 and 26 April 2022, with a return to face-to-face ceremonies on 7 July 2022.

The 10-week program aims to improve women's health and wellbeing through a series of workshops, presentations and healthy activities. ## **Policies and Related Council Documents**

All relevant Council policies have been taken into account in preparing the current initiatives outlined within this Mayoral Focus report, the final in a series of updates on the 2021-22 Mayoral Program. Preceding reports were noted by Council on 8 February 2022, 10 May 2022 and 9 August 2022.

## Legal/Statutory Obligations and Risk

The Mayoral Program is an important activity: as the leader of Council the Mayor has a number of roles which are both legislative and functional. The legislative requirements are outlined in sections 18 and 19 of the *Local Government Act* 2020. The Mayor not only takes precedence at all municipal proceedings within the municipality but must also take the chair at all meetings of Council at which they are present.

As reflected in the Mayoral Program, the Mayor's role extends well beyond officiating at Council meetings or other municipal proceedings. It includes providing leadership, promoting positive relationships and modelling good governance.

The requirements of the *Charter of Human Rights and Responsibilities Act* 2006 have been considered when writing this report.

## **Financial and Resource Implications**

The initiatives in the Mayoral Program are supported by the existing budget.

## **Environmental, Social and Economic Impacts**

The Mayoral Program has a strong focus on environmental sustainability and a community focus on access and social inclusion.

## **Consultation and Communication**

Relevant Council departments have been consulted for an update on the progress on the activities and initiatives included in the 2021-22 Mayoral Program.

If community consultation is required for any part of the program, it will be carried out appropriately.

## **Declaration of Conflict of Interest**

Section 130 of the *Local Government Act* 2020 requires members of Council staff to disclose any general or material conflict of interest in matters to be considered at a Council meeting.

Council staff involved in the preparation of this report have no conflict of interest in this matter.

## 8 Election of the Mayor

The procedure for the election of the Mayor will follow section 25 of the *Local Government Act* 2020 and section 2 of the Hobsons Bay Governance Rules.

## 8.1 Determination of Mayoral Term

In accordance with section 26 of the *Local Government Act* 2020 and rule 2.1.2 of the Hobsons Bay Governance Rules, Council must resolve whether the Mayor is to be elected for a one-year or a two-year term.

### Recommendation

That Council:

- 1. Resolves the Mayoral term to be a period of one year commencing upon the election of the Mayor on 11 November 2022.
- 2. Notes that the next election of the Mayor, to be determined when Council adopts its annual timetable of meetings, must be held on a day that is:
  - a. As close to the end of the one-year term as is reasonably practicable
  - After the fourth Saturday in October and no later than 30 November 2023, in accordance with rule 2.2.1 of the Hobsons Bay Governance Rules
- 3. Notes that the date and time of the next election of the Mayor will be determined when Council adopts its annual timetable of meetings in accordance with rule 2.3.1, and published on Council's website in accordance with rule 4.2.3, of the Hobsons Bay Governance Rules.

## 8.2 Election of the Mayor

The Chief Executive Officer will invite nominations for the Office of Mayor.

In accordance with section 25(6) of the *Local Government Act* 2020, if only one Councillor is nominated, the meeting must declare that Councillor to be duly elected as Mayor.

Where two or more nominations are received, Council shall vote to elect the Mayor by show of hands, in accordance with rule 2.6.6 of the Hobsons Bay Governance Rules.

The Mayor, once elected, will be robed in the Council Chamber by the Chief Executive Officer and will be presented with the Mayoral Chain of Office. The Mayor will then chair the remainder of the meeting.

## 8.3 Mayoral Response

The Mayor will address the meeting and invite other Councillors to respond.

## 9 Election of the Deputy Mayor

The Mayor will invite nominations for the Office of Deputy Mayor.

In accordance with rule 2.8.2 of the Hobsons Bay Governance Rules, the election of the Deputy Mayor will follow the same process as for the election of the Mayor.
