- the foster animal remains the property of the Hobsons Bay City Council at all times and I must return the animal to Hobsons Bay City Council when requested to do so;
- I will not attempt to arrange the adoption or sale of any animal fostered to me, nor will I seek to adopt any such animal without the prior authorisation of the Hobsons Bay City Council;
- Hobsons Bay City Council is not responsible for any damage caused by the foster animal to my home, possessions, property, or to me or any person or animal during the foster period agreed with Hobsons Bay City Council and otherwise while the animal is in my care;
- I am responsible for the foster animal and its actions during the foster period and otherwise while the animal is in my care, and I indemnify Hobsons Bay City Council against any loss, liability or expense suffered or incurred by Hobsons Bay City Council out of or in connection with any event or incident involving the animal that occurs during this period;
- I am not legally disqualified from keeping any animal and I will ensure that I comply with all laws relating to keeping an animal during the foster period and other wise while the animal is in my care.

I also agree to:

- take the animal into temporary care for the foster period and ensure that the animal is kept in safe and appropriate areas and with appropriate facilities and equipment;
- take good care of the animal;
- provide clean, dry, comfortable housing and bedding for the animal;
- regularly monitor the animal for any signs of illness or injury and to contact the Hobsons Bay City Council as soon as possible where such signs appear;
- return the animal to Hobsons Bay City Council at the end of the foster period;
