The Chairperson noted that all Councillors were present and that Cr Peter Hemphill was joining the meeting virtually.

The Chairperson asked whether any Councillors needed to disclose a conflict of interest. No conflicts were declared.

## 5 Election of the Mayor

The procedure for the election of the Mayor followed section 25 of the *Local Government Act* 2020 and section 2 of the Hobsons Bay Governance Rules

## 5.1 Determination of Mayoral Term

In accordance with section 26(3) of the *Local Government Act 2020* and rule 2.1.2 of the Hobsons Bay Governance Rules, before the election of the Mayor, Council must determine by resolution whether the Mayor is to be elected for a one-year or a two-year term.

#### Recommendation

#### **That Council:**

- 1. Resolves the mayoral term to be a period of one year commencing upon the election of the Mayor on 10 November 2023.
- 2. Notes that the next election of the Mayor, to be determined when Council adopts its annual timetable of meetings, must be held on a day that is as close to the end of the one-year term as is reasonably practicable.

#### **Motion**

Moved Cr Antoinette Briffa, seconded Cr Diana Grima:

#### **That Council:**

- 1. Resolves the mayoral term to be a period of one year commencing upon the election of the Mayor on 10 November 2023.
- 2. Notes that the next election of the Mayor, to be determined when Council adopts its annual timetable of meetings, must be held on a day that is as close to the end of the one-year term as is reasonably practicable.

## 5.2 Nomination and Election of the Mayor

The Chief Executive Officer invited nominations for the Office of Mayor.

## **Nominations for the Office of Mayor**

Cr Matt Tyler was nominated by Cr Jonathon Marsden and accepted the nomination.

Cr Pamela Sutton-Legaud was nominated by Cr Peter Hemphill and accepted the nomination.

## **Election of the Mayor**

As multiple nominations were received, a vote by show of hands was conducted to elect the Mayor, in accordance with rule 2.6.6 of the Hobsons Bay Governance Rules.

The Chief Executive Officer put Cr Tyler's nomination to the vote.

For: Cr Antoinette Briffa, Cr Diana Grima, Cr Jonathon Marsden, Cr Matt Tyler

The Chief Executive Officer put Cr Sutton-Legaud's nomination to the vote.

For: Cr Peter Hemphill, Cr Daria Kellander, Cr Pamela Sutton-Legaud

As Cr Tyler received an absolute majority of votes, the Chief Executive Officer declared Cr Tyler to be duly elected as Mayor.

Shortly after announcement of Cr Tyler's election, the meeting had to be temporarily halted due to a member of the public causing a disruption in the chamber.

#### **Motion**

Moved Cr Antoinette Briffa, seconded Cr Daria Kellander:

That the meeting be adjourned for ten minutes.

Carried

The meeting was adjourned at 7.32pm and resumed at 7.53pm.

## **Motion**

Moved Cr Antoinette Briffa, seconded Cr Daria Kellander:

That the meeting be recommenced.

Carried

Upon recommencing the meeting, the Chief Executive Officer as Chairperson repeated the announcement that Cr Tyler had been elected Mayor.

Cr Tyler was robed by outgoing mayor Cr Briffa and presented with the mayoral chain of office by the Chief Executive Officer, and took the central seat of the meeting as Mayor.

The Chief Executive Officer invited Councillors to speak. All Councillors offered congratulations to Cr Tyler on his election.

The Chief Executive Officer also offered Cr Tyler his congratulations and formally passed over the Chairperson role to Cr Tyler for the remainder of the meeting.

## 5.3 Mayoral Response

Cr Tyler thanked the Chief Executive Officer and Councillors for their kind words, and thanked Cr Sutton-Legaud for accepting her nomination for Mayor, saying that it was an important part of the democratic process to have a vote.

He thanked everyone in the room for their support and for what they do to make the community better, and that it was a great honour to be here and that he would not take the role of Mayor for granted but would give "absolutely everything" to it.

Regarding his future mayoral program, Cr Tyler said that he felt there were some significant challenges this year and that he intends to develop the mayoral program in collaboration with his colleagues, but wanted to touch on some of what motivates him in his role: significant initiatives including social housing at Laverton, investments in open space and physical infrastructure such as libraries, and advocacy such as relationships with federal members of Parliament.

Cr Tyler commended Councillors and Council staff for their efforts to help people in the community, and concluded his speech with personal thanks to his mum and to his wife Sarah.

## **6 Election of the Deputy Mayor**

## 6.1 Nomination and Election of the Deputy Mayor

#### **Nominations for the Office of Deputy Mayor**

Cr Pamela Sutton-Legaud was nominated by Cr Daria Kellander and accepted the nomination.

## **Election of the Deputy Mayor**

As there were no further nominations, the Chairperson declared that Cr Sutton-Legaud was duly elected deputy mayor.

The Chairperson called for Councillors to respond. All Councillors offered congratulations to Cr Sutton-Legaud.

## **6.2 Deputy Mayoral Response**

Cr Sutton-Legaud congratulated Cr Tyler on his election and said that she was delighted to be the deputy mayor, and that she thought it would be an exciting year with an upcoming election and much to do between now and then.

Cr Sutton-Legaud said that she hoped that members of the community know they can call on her and she will listen to them, and that she cares about what is happening across the municipality, highlighting that even though councillors are elected to specific wards, they represent the whole of Hobsons Bay.


## 7 Close of Meeting
